600.2559(1)(h) ^{1,3,7}	Levy under or service of an order to seize property and any accompanying paper.	\$35.00
600.2559(1)(k) ^{1,7}	Each notice of sale under an order for the seizure of property or construction lien posted in a public place in the city or township.	\$21.00
600.2559(1)(l) ^{1,4}	Order of eviction or a writ for the restitution of premises.	\$35.00

¹Fee, Plus Mileage: Mileage under 600.2559(1) shall be 1½ times the rate allowed by the state civil service commission for employees in the state classified civil service. See [Treasury letter 2005-6](#). Mileage is computed each way, by the shortest distance from the place where the court that issued or filed the process or paper is located to the place of service. - ²600.2559(1)(d) Fee plus mileage plus the actual and reasonable expense of seizing, keeping, and delivering the goods.
- ³600.2559(1)(h) Fee plus mileage plus the actual and reasonable expense for seizing and keeping the property.
- ⁴600.2559(1)(l) Fee plus mileage plus the actual and reasonable expense for the physical removal of property from the premises.
- ⁵600.2559(1)(n) Fee plus mileage plus a reasonable fee per hour for the amount of time involved in executing the warrant.
- ⁶600.2559(1)(o) Fee plus actual cost of postage.
- ⁷600.2559(8) “Order for the seizure of property” includes a writ of attachment and a writ of execution, including, but not limited to, execution in a claim and delivery action on property other than the property that is the subject of the claim and delivery action.

ADDITIONAL NOTES:

Additional information for the following MCL numbers:

- 600.2559(1)(i)⁷ For seizure of property under an order for the seizure of property in an action in which a judgment is entered against the owner of the property, regardless of whether the judgment is entered before or after the order is issued, and if the judgment is satisfied prior to sale of the seized property by full payment of the judgment or settlement: 7 percent of the first \$5,000 of the payment or settlement amount and 3 percent of the payment or settlement amount exceeding the first \$5,000.00.
- 600.2559(1)(j)⁷ For sale of property seized under an order for the seizure of property: 7 percent of the first \$5,000 in receipts and 3 percent of any receipts exceeding the first \$5,000.
- 600.2559(3) Fee and mileage is in addition to fees and mileage allowed under 600.2559(1).
